RIXML.org Releases v2.5 of RIXML Research Standard

New York, NY – Following a 30-day comment period, version 2.5 of the RIXML Research Standard is now the official production version, effective immediately.

Responding to feedback from member firms and other interested parties, RIXML Research version 2.5 contains several enhancements designed to provide increased flexibility and usability, and includes the following:

- three new Index types have been added, expanding coverage of non-US markets, and enabling publishers to more accurately describe the topics of their research.
- four new Status types have been added, enabling publishers to specify different workflow conditions for updating and re-posting research.
- four new Entitlement sub-types have been added, so publishers can define entitlements based on new criteria.
- structures have been added supporting names in multiple languages. Organization Name, Person Name, Team Name, Title, Sub-Title, Synopsis, and Abstract can all be specified in any number of alternative languages relative to the primary language of the research.
- support for Events has been broadened by adding two new Product Categories for Event Invitations and Post-Event Summaries
- Specialty has been added as something that can be "covered" by analysts and publishers in our Coverage Updates Standard
